You may CANCEL this contract at any time until ten (10) days after you receive a copy of this contract. You do not need a reason to cancel.

If you do not receive the goods or services within seven (7) days after the agreed delivery date, you will be notified of any delay. If the order does not arrive within twenty-one (21) days of the agreed delivery date, you may cancel the order. You may cancel this contract within one year of the contract date. You lose that right if you accept delivery after the twenty-one (21) days. There are other grounds for extended cancellation. If you cancel this contract, the seller has fifteen (15) days to refund your money and any trade-in or the cash value of the trade-in. You must then return the goods.

To cancel, you must give notice of cancellation to the demonstrator whose name and address appear on the front of this form. You must give notice of cancellation by a method that will allow you to prove that you gave notice, such as registered mail, fax or personal delivery.
